2	The member concerns of the Chamber desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof.	15 th July, 2019 Monday
3	The Secretary General shall display the list of all members eligible to vote along with their National Tax Registration Number, Sales Tax Registration if applicable, the name and national identity card number of their representative at Notice Board and website of the Chamber.	19 th July, 2019 Friday
4	The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General. {TOR-2013, 18(2)}	26 th July 2019 Friday
5	The Secretary General will intimate action on the objection or changes sent by members.	31 st July, 2019 Wednesday
6	Any member aggrieved by the decision of the Secretary General, taken in the preceding clause, may make a representation to the Election Commission.	3 rd August, 2019 Saturday
7	The Election Commission will decide the representation.	5 th August, 2019 Monday
8	Any person aggrieved by the decision of the Commission or where the Commission fails to decide the representation within the stipulated time mentioned in the preceding clause may appeal to the Regulator, and decision of the Regulator in this regard shall be final. {TOR-2013, 18(7)}	8 th August, 2019 Thursday
9	Regulator will decide the appeal.	23 rd August, 2019 Friday
10	The final list of voters shall be displayed at notice board and at website of the Chamber and shall also be submitted to the Regulator.	26 th August, 2019 Monday
11	Any person who is eligible to contest the Election for the vacant post of the Member Executive Committee shall send his nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Articles of Association of the Chamber.	29 th August, 2019 Thursday
12	Secretary General shall provide a copy of final list of voters to each contesting candidate.	30 th August, 2019 Friday
13	Scrutiny of the nomination papers and letter of authority by the commission.	31 st August, 2019 Saturday
14	Circulation by the Secretary General of the list of nominees whose papers have been declared valid and the forms of withdrawal to the said nominees.	31 st August, 2019 Saturday
15	The objection, if any, to the nomination of candidates can be filed to the election Commission.	2 nd September, 2019 Monday

16	The election commission will decide the objections filed under the preceding clause.	4 th September, 2019 Wednesday
17	Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause, where the Commission fails to decide within the time stipulated in the preceding clause may file an appeal to the Director General.	7 th September, 2019 Saturday
18	The Regulator shall decide the appeal preferred under the proceeding clause.	14 th September, 2019 Saturday
19	The Secretary will receive the withdrawals form the nominees completed by the nominee who want to withdraw from the election.	16 th September, 2019 Monday
20	The Election Commission will issue final list of candidates	17 th September, 2019 Tuesday
21	Polling for Executive Committee at the registered office of the Chamber. {TOR-2013, 18(15)} Election commission may declare provisional election results.	23 rd September, 2019 Monday
22	Any member elected by general body in voting as E.C member shall send his nomination for election as an office bearer duly proposed and seconded by an elected E.C. member and signed by the candidate to the Election Commission.	25 th September, 2019 Wednesday
23	Scrutiny of the nomination papers for the election of office bearers by the Election Commission and display of final list of candidates	26 th September, 2019 Thursday
24	Polling for the election of office bearers (President/Senior Vice President/Vice President) {TOA-2013, 2(K)}.	28 th September, 2019 Saturday
25	The announcement of election result shall be made in Annual General Meeting (AGM) of the Chamber called for this purpose.	30 th September, 2019 Monday
